Committee and coordinator in all functions and public relations programs and appearances, as the Committee and coordinator see fit.

- 6. Any candidate may be dismissed from competition at the sole discretion of the Committee.

Each parent who has legal and/or physical custody of the above-named child hereby release(s) and forever discharge(s) the Committee, its officers, members and sponsors, and each of them, the City of Northfield (hereinafter City), its officers and employees, and Elko Speedway, (hereinafter Speedway) its officers, members and employees, and agree(s) to hold the Committee and its officers, members and sponsors, the City, its officers and employees, and Speedway, its officers, members and employees, harmless from any and all liabilities direct or indirect, for personal injury or property damage which I/we or the above-named child, may suffer during the Celebration, including the time of the contest for Defeat of Jesse James Days Junior Royalty, and, in the event said child is chosen as a member of the Junior Royalty, then during the year of his/her reign. This Release shall not be effective if the injuries are caused directly by the willful misconduct of the Committee, its officers, members and sponsors.
